8. EXPOSURE CONTROLS/PERSONAL PROTECTION

8.1 Control parameters

Occupational Exposure Limit:	No exposure guidelines established by ACGIH, NIOSH or OSHA. Amgen recommends an occupational exposure limit (OEL) of 750 μ g/m ³ as an 8-hour time weighted average over a 40-hour work week. The OEL is designed as an acceptable airborne concentration of a substance for which it is believed that workers may be repeatedly exposed day after day without adverse health effects. Romosozumab has been classified per Amgen's Hazard Classification System as an Occupational Exposure Band 2 compound (100 μ g/m ³ - 1,000 μ g/m ³).
Engineering Controls:	When practicable, handle material in enclosed processes or in processes with effective local exhaust ventilation or within a chemical hood.

Personal Protective Equipment	
Eye/face Protection:	Wear safety glasses with side shields, chemical splash goggles, or safety glasses with side shields and a full-face shield to prevent contact with eyes. The choice of protection should be based on the job activity and potential for exposure to the eyes and face.
